- a. The Village of Lipton has served formal notice that the Fire Protection Agreement will expire as of August 4th, 2019. The issue is the cost sharing agreement between the Village and the Municipality.

- c. Approve the Weed Management Plan for 2019. The high priority of the plan is to inventory the invasive plan species and to control and eradicate, as well as noxious weeds. Medium priority will be the control and eradication of prohibited species.
