# Call to Order:

Reeve Senft called the meeting to order at 8:00a.m.

# Agenda:

#### #121/19-SLYWKA:

# **Minutes Regular Meeting:**

### #122/19- VAN LUVEN:

That the minutes of the May 10th, 2019 Regular Meeting be adopted with an amendment to Councillor Slywka's report by changing the name of the Freeland to the Strasburg Road as to gravel requirements.

That the May financial report be accepted as presented.

## **Accounts Payable:**

#### #124/19-MILLER:

That the accounts payable represented by cheque No.4179 to 4196, payroll accounts 527 to 529 in the amount of \$36,410.50 and direct payments for utilities through the bank in the amount of \$598.13 be approved.

## Delegation:

Roger Junek representing the Lower Qu'Appelle Watershed Stewards and Rachel Kraynick representing the Ministry of Agriculture made a presentation to Council as to a pilot project for the decommissioning of old wells not in use and that the funding for this project is a 90%-10% cost share between the Province and the property owner. Should the Municipality support the program, that the ratepayers be informed by a general mail out of the program. The representatives further informed Council on the funding available for Farm Stewardship Programs.

Reeve Senft thanked the presenters and stated that Council would discuss the program and inform the LQWS of their decision.

# LQWS Decommissioning Well Program:

#### #125/19-MILLER:

That the Municipality partner with LQWS in the decommissioning well program, with the Province funding 90% of the cost and that the Municipality would fund the additional 10% and invoice the property owner who has requested to have a well(s) decommissioned for that amount. Should the invoice it not be paid by year end, that the Municipality will place that cost on their taxes, and further that an information flyer be mailed out to the property owners with their 2019 tax notice.

### Road Tour 2019:

#### #126/19-CZEMERES:

That the Council set the date of Monday, July 8<sup>th</sup>,2019 at 8:00 a.m. for a road tour of the municipality's roads.

### **Council Reports:**

#### Division 1:

Councillor Huber expressed concern that the gravel on the Hayward was grading to the side over the edge of the road when the rock removal was in process, and that it cannot be recovered which is an additional cost to the municipality for gravel. He inquired if he should proceed with the repair of the road to give access to the NW-2-23-13-W2, which was quoted at \$5,000 by

Hired Gunn Construction in 2018, but the weather did not permit it to be completed.

#### Division 2

Councillor Van Luven that in general the roads in Division 2 are in good condition. On the road tour, review the road into the lands east of section 20-22-14-2 in an desire to finalize the issue of the bush and access. Councillor Van Luven inspected the north fence line on the SW30-22-14-W2 and is of the opinion that the fence is in reasonable condition and does not have to be rebuild.

## Division 3

Councillor Czemeres informed Council that the roads are in good condition. He stated that the rocks have not been picked on the road edges and that the mower operator be directed to pick the rocks prior to cutting the grass as to not cause damage to the mower.

#### Division 4

Councillor Slywka stated rocks on the Strasburg should be capped with clay as the repair done in the wet years was with rock to hold the road. Perhaps this can be looked at during the road tour and include the clay capping of the portion during the clay-capping of the Strasburg. He attended the Parkland Regional Library Boards AGM, and that there is an outstanding levy not paid by the City of Yorkton as being a member of the Regional Library District. He informed Council that the Cupar Nursing Home upgrades would be completed by the end of July.

### Division 5:

Councillor Miller informed Council that the gravel hauler, KF Aggregates has issues with their drivers not obeying the traffic regulations as to Yield signs and being courteous when traveling on the Strasburg when meeting on-coming traffic. She had KF Aggregates place calcium chloride on the Strasburg in front of Walter Nakonechny's property, as it is within 100 metres of the road. Mr. Nakonechny stated that he would do his own dust control on the Freeland as in previous years and asked that it not be graded

#### Division 6:

Councillor Arthur stated that the dust control on the Dysart North as per the Municipality's policy is well done, and the rocks on the Dysart north have been removed and the road graveled from the Strasburg to Highway #22. He has an issue with a fence on the west boundary road, the fence is within the right of way and a farmer expressed concern that he cannot get his equipment down the road. He will do an onsite inspection and hopefully resolve the matter. Councillor Arthur informed Council that he spoke to the owner of KF Aggregate and the RCMP relating to their drivers not practicing traffic rules as to the yield sign as they approach the #639 Grid. Councillor Arthur would like to see the yield signs changed to stop signs at that location.

#### Reeve:

Reeve Senft stated that he had a call from Daryl Huber regarding the bush on the road allowance East of Section 20-22-14-W2 and informed him that the original Council motion is active, that being to have the bush removed by June 30<sup>th</sup>, but with the road tour set for July 8<sup>th</sup> the situation may change as Council meets on the 12<sup>th</sup> of July.
