### **Council Reports:**

#### Division 1:

Councillor Huber stated all the roads are mowed in his division and the roads are in good shape. He did obtain quotes for a new tractor. There are some dead trees that have fallen on the backroads. He is waiting for the mulching in his area, as some of the area has been cleared, however he has other areas that can be mulched. He stated he did have a complaint regarding the fence on the SE-19-22-13-W2.

#### Division 2

Councillor Van Luven informed Council that the fence mentioned in Councillor Huber's report was his fence and that it would be removed, he further filed with Council a written response to the fence concern.

#### Division 3

Councillor Czemeres stated that he did some repair with the pay-loader on the south boundary road with Jackson Bros., which was clearing some beaver brush and filling in a beaver run. He suggested that Public Works change the yield sign to a stop sign on Township Road 232 where it enters onto the #639 Grid. He stated he was informed that the culverts were plugged Range road 2145 and Township Road 224. Councillor Van Luven responded to the concern regarding the culverts being plugged.

#### Division 4

Councillor Slywka stated that the repair work on the shoulder of Range road 2131 has been completed and the repair consisted of a rock layer and covered with clay, so the erosion will be stopped.. The gravel explorations consisted of test holes on the SE of 4-24-14-W2, and the material was a fine gravel/sand mix with no rock. The existing pit on the Wager pit, and there appears to be at least two more crushed of 15,000 yds. each.

#### Division 5:

Councillor Miller stated that the rocks are showing up on the Strasbourg Grid and should be dug out in the Spring, in general the roads are in good condition. She did some spot graveling from the Goff road south to the Canterbury. There is a couple of miles of back road that could be cut, being east of section 27-34-24-14-W2. There was a concern regarding the custom mower operator using his own mower versus the RM more, however there were hydraulic issues as to hook ups and it was discussed and verbally approved. Tami did a good job grading for the remainder of the season.

#### Division 6:

Councillor Arthur stated the Nistor road required mowing again as these were early cuts and the growth will cause winter snow blocking. Councillor Arthur inquired about the road base and test drilling that was to be done, he was informed that it has been completed, except for test holes for the clay required to construct the road on the land adjacent to the #639 Grid. He questioned why the RM didn't have signage stating you are entering the RM of Lipton. No. 217 at certain points entering into the municipality. There are no signs on highway #22 and 35.

#### Reeve:

Reeve Senft stated he was concerned about the snow removal and the personnel available as with one operator it takes approximately 4 days to do the Municipality depending on the volume of snow. Perhaps Council should explore the possibility of an additional part-time operator for emergencies.

The excavation and crushing site shall be 400 metres from any dwelling.

The site is to be reclaimed as follows: Upon commencement of opening the gravel pit, the top soil shall be piled in a

manner that it can be used for reclamation of the site.

Upon completion of the gravel extraction, the slopes of the excavation of the gravel pit shall be sloped to a 4:1 slope and the top soil spread over the site and be seeded to grass.

The operation shall meet Provincial and Municipal standards.

Prior to final reclamation approval, the Municipality shall be notified and an inspection of the site will be carried out with the contractor or owner.
