Council Reports:

Division 1:

Councillor Huber stated that the road the roads are dry and dusty. There was some trees down on the back roads, the grader operator moved them off to the side. He noticed rocks on the edges of the seasonal roads and hopes that they will be picked up prior to mowing. He questioned when the seasonal roads will be graded.

Division 2

Councillor Van Luven absent from the meeting.

Division 3

Councillor Czemeres stated that he graveled some seasonal/backroads and had stones removed from the driving surface.

Division 4

Councillor Slywka stated the intersection off Range road 2135 and Township 234 will require some brush being cut back for sight lines. He informed Council that the administrator of the Cupar Senior Home is retiring. The Cupar Senior Home is in the process of upgrading the beds in the facility.

Division 5:

Councillor Miller the grading of the roads is going well, washboard is showing up, perhaps due to the dry weather. Rocks were removed from the seasonal road east of 13-24-14-2, and she received a complaint about the potholes relating to the stones being removed. The road was graded and it appears all is fine. Rocks were also removed south of 14-24-14-W2.

The road was inspected by Councillor Arthur and the Foreman and there is ample gravel at this time.
